## Equine Activity Release & Hold Harmless LESSON/TRAINING Agreement

I \_\_\_\_\_ (legal age or guardian) the undersigned have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with the representative/equine paraprofessional \_\_\_\_\_ understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies) associated with the equine facility, staff or animals. I further warrant I am of legal age to enter into this agreement on behalf of myself or as guarding/parent of minor child.

I understand the potential dangers that I, rider or paraprofessional could incur in mounting, riding, walking, boarding, feeding the said horse(s); including, but not limited to, any interactions with other horses. Understanding those risks I hereby release Ridesport Stables, its officers, directors, shareholders, employees and anyone else directly or indirectly connected with Ridesport Stables from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to mount and ride a horse owned, leased or operated by equine paraprofessional or RideSport Stables.

I understand and recognized and warrant that this Release and Hold Harmless Agreement, being voluntarily and intentionally signed and agreed to, and that in signing this Release and hold Harmless Agreement eliminates the liability of said equine paraprofessional to include any activity, whatsoever, involving an equine, including death, personal injury and/or damage to property, your person, or your property.

I recognize and agree that I know this equine paraprofessional: \_\_\_\_\_, with whom I will be working with, and acknowledge that I agree said equine professional has made reasonable and prudent efforts to determine by ability to engage in the equine activity, and has sufficient knowledge of my equine and horseback riding skills as to relieve, release and hold harmless said equine professional and RideSport Stables from any continuing duty to monitor my equine activities.

I further voluntarily agree and warrant to Release and Hold Harmless this equine professional from any liability whatsoever, including, but limited to, any incident caused by or related to said equine professional's negligence, relating to injuries known, unknown or otherwise not herein disclosed; including, but not limited to, injuries, death or property damage from: Mounting; riding; dismounting; walking; grooming; feeding; use of horse barn, paddock, trails or riding arenas, in any capacity; falling of horse whether horse is bucking, flipping, spooked, jumping; or my failure to understand any of the equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse I have been assigned to.
